INSPEC announces partnership with Ask IEEE

In a move expected to significantly enhance the ease and convenience with which engineering, computer science and physics professionals obtain documents, INSPEC, the information services division of the Institution of Electrical Engineers (IEE), has formed a partnership with Ask IEEE to provide article delivery of all IEE and IEEE publications, as well as publications covered by the INSPEC database. The service will be launched in January 1994.

Ask IEEE, a service of the Institute of Electrical and Electronics Engineers (IEEE) launched last year in cooperation with Dynamic Information Corp., is a one-stop document delivery service specialising in engineering, computer and physical sciences information with access to virtually any document in the public domain. Ask IEEE will now hold three core collections. It holds all current and retrospective IEEE publications, including journals, books, conference proceedings and standards. To this is now added all current and retrospective IEE publications and, beginning from late 1993, virtually all materials indexed by the INSPEC database. In addition to individual articles, customers can also purchase any in-print or out-of-print IEE or IEEE conference proceedings, book or standard in its entirety directly from Ask IEEE.

"Since its launch scarcely one year ago, Ask IEEE has proved it can quickly, economically and efficiently serve the needs of the information community," said Rod Montrose, IEE's Managing Director of Publishing and Information Services. "Without doubt the strength and quality of the publications of the IEE, INSPEC and IEEE, combined with the expertise of Dynamic Information Corp., will provide a new level of excellence in technical document delivery."

Phyllis Hall, IEEE Staff Executive, Publications, said the new availability of the full-text documents for INSPEC records as part of the Ask IEEE collection is the latest in a strong, continuing relationship between the US-based IEEE and the UK-based IEE.

"We are pleased to be able to provide our customers with the premier technical document delivery service," she started. "INSPEC's endorsement of Ask IEEE as their preferred deliverer recognizes the strength of our ability. The IEEE's immense collection of its own literature in electrical and electronics

engineering and computing, linked with INSPEC's renowned collection in physics, electronics, and computing, clearly make Ask IEEE the superior document delivery service for technical professionals."

Monrose and Hall observed that, as is currently the case with all documents delivered by Ask IEEE copyright royalties for INSPEC documents obtained through the service will automatically be paid either directly to publishers or to the Copyright Clearance Center (CCC).

As with other Ask IEEE documents, orders received by noon Pacific Time for INSPEC materials will be shipped the same day at no extra cost. Delivery is made at the customer's option: fax, e-mail via Ariel Fax, overnight express, or mail.

INSPEC, the information services division of IEE, produces the INSPEC database, which provides abstracting and indexing to the world's literature in physics, electrical engineering, and computing, including all literature of the IEEE and IEE. The database dates back to 1969 and contains more than 4.5 million bibliographic records. Each year INSPEC adds more than 280,000 records to its database, regularly scanning the contents of some 4,200 journals, 2,000 conference proceedings and selected books, reports and dissertations.

Rates from the IEE, and IEEE collections are \$10 for members, and \$12 for others. Rates for materials from the INSPEC collection are \$10 plus copyright for IEE and IEEE members and \$12 plus copyright for others. Orders for documents outside the INSPEC, IEE, and IEEE core collections cost slightly more.
